Department Reports

Administration / Planning Commission:

Clerk – Tax collection went well. Auditors will be in the office the week of Feb.13 – 17. Spring primary will be on Feb. 21^{st} . Update on caucus nominations and candidates on spring ballot. Bergmann – No Planning Commission news to report. Discussion of Clayton Cheese Days events, coordination, and promotion.

Donath – Reviewed recent Police Commission meeting minutes.

Public Works & Utilities:

Two Public Works employees will be attending MSHA refresher course on Feb. 21. Board approved village plowing on Lake Magnor for ice fishing contest by affirmation. Update on 2017 water monitoring requirements.

Police Department:

The department logged 37 calls for service, made 1 arrest, and issued 6 citations and 8 warnings. 24 training hours were attended. There were 10 new cases, 2 assists to other departments, 1 outside assists to the Clayton PD, 2 court hours, 0 animal complaint, and 0 hours of foot patrol. 625 miles were put on the squad car.

Fire Department:

There were 2 fire calls and 2 medical calls in January. Fire Dept. is facing approximately \$20,000 in upgrade costs of turn-out gear, SCVA bottles, and a larger capacity compressor. Discussion of need to update fire protection agreements with municipalities served. Clear Lake Ambulance has asked Clayton First Responders for help with a portion of the Township of Clear Lake.
