Motion by Schradle to approve the minutes from the February 04, 2019 regular board meeting and the February 13, 2019 special meeting, second by Scharmer. Voice vote: Ayes-6 Nays-0 Motion carried.

Motion by Schradle to accept the Treasurer's January, 2019 bank reconciliation and the February, 2019 check register, second by Scharmer. Voice vote: Ayes-6 Nays-0 Motion carried.

Public comment:

Motion by Scharmer to allow Chief Parr to keep the village squad car housed at his home in Chetek during the summer period when the Grosskreutz family is home –or- until an alternative plan is approved, second by Krueger. Voice vote: Ayes-6 Nays-0 Motion carried.

NLR Rentals to date has not developed a parking plan in order to have their rezoning request acted on.

Department Reports

Administration / Planning Commission:
