The Village has been working with Rural Development on possible grant money available to build a new wastewater treatment facility. Rural Development is offering 37% grant money to do this project. The Board made a motion to continue working with Rural Development and move forward with the project. Motion made by Anderson and seconded by Bartz.

Department Reports:

The Administration Dept. motion by Anderson and seconded by Donath to allow Cally to take out a short term loan up to \$25,000 for 90 days to get the Village through until Shared Revenue is paid out in July Ayes-5 Nays-0 motion carried. The Board was updated on what happened at the Plan Commission meeting on March 18th. Jim Alt the Zoning Administrator updated the Board on Zoning applications he has been working on for the dug outs at the school.

The Public Works Department is still working on the Baker Street Project. Clean up day will be May 10th from 8 am to 12 pm. Sheldon is going to check on prices for water tower annual inspections, Sheldon has 2 prices and is waiting for a 3rd price. The Village will need to purchase a sewer sampler in the future it will be put on May's agenda.

Police Department-Reported in March there were 1098 miles put on the squad, 0 arrests, 14 citations, 8 warnings, 2 training hours, 20 new cases investigated, 11 assists to outside agencies, 5 assists received from outside agencies, 3 court hours of court related matters, 3 animal complaints, and 3 hours of foot patrol.

Fire Chief Groehler reported there were 2 fire and 3 medical calls in March.
