The Public Works Department- There still has been discussion on the new driveway on 80th ave. The DPW committee discussed the ballfield lighting issue and the need to get work done. Police Department-Reported in July there were 1024 miles put on the squad, 2 arrests, 5 citations, 14 warnings, 4 training hours, 14 new cases investigated, 4 assists to outside agencies, 3 assists received from outside agencies, 5 court hours of court related matters, 2 animal complaints, and 2 hours of foot patrol.

The PD committee discussed moving along looking into starting the part time hiring process.

Fire Department - reported there was 0 fires, 4 medical calls, and 1 car accident in July. Clayton Benefit Pull is September 5, 2015 at the Fire Hall and pulling track.
