1. CALL TO ORDER

Village President Jenny Bergmann called a regular meeting of the Village of Clayton Board of Trustees to order at 7:00 p.m. Roll call: Jenny Bergmann, Scott Donath, Shawn Schradle, Dennis Heiken and Doug Anderson. Jon Bartz was absent. Also present were Public Works Director Sheldon Donath, Police Chief Grant Pickard, Bob Kazmierski, Bill Vanda, Barb Young, Cathy Shimon, Joe Berghammer, LaMoine & Mary Ellen MacLaughlin. Travis Krueger attending the meeting at 7:45 PM. All joined to salute the flag.

13. DEPARTMENTAL REPORTS

- i) Administration/Plan Commission/Zoning:
 Court proceeding moving forward on Mobile Home Park. Polk County EDC annual fee of \$1 per capita (\$571) discussed. Motion by Donath to approve claim, second by Anderson, voice (roll call) vote: Ayes-6 Nays-0 motion passed.
- ii) Public Works & Utilities:
 - Ballpark lights are down, repairs needed. New Phase loss monitor installed at Well #3. However, Well #3 is currently offline due to making noise. Vendor will be asked to come and evaluate. Need to consider stop sign and/or three way stop at the intersection of Polk Ave and Clayton Ave. Village Board has concerns with other crossings as well. Chief Pickard will monitor intersection, do research and provide recommendation at this and other intersections.
- iii) Police Department:
 - Reported in August there were 740 miles put on the squad, 0 arrests, 5 citations, 16 warnings, 6 training hours, 11 new cases investigated, 4 assists to outside agencies, 4 assists received from outside agencies, 3 court hours of court related matters, 2 animal complaints, and 2 hours of foot patrol. The PD hiring process will be closing September 25, 2015.
- iv) Fire & First Responders:

Reported in August there was 0 fires, 3 medical calls, and 0 car accidents. Clayton Benefit Pull raised roughly \$12,000 for the cause had an excellent day and THANK YOU to all who helped, supported and attended. Clayton, as a community, received excellent exposure and benefit shirts are still available for sale at the Fire Hall.
