Department Reports

Administration / Planning Commission:

Dawn Nelson reported that the 1st batch of property taxes were submitted and it was a lot easier than expected.

Police:

Fire & First Responders:

Fire Chief Bill Vanda reported that there were 7 medical calls in December. Chief Vanda said the fire department will contract out inspections for 2022. There will be 55 inspections twice a year and that fee will come out of the 2% dues.

Parks & Rec:

Discussion topics included the Wayside Park and the playground equipment. There is a meet raffle at Charlies Place on January 7th. Parks & Rec received a \$1600 donation for Foremost. There is a cheese days meeting on January 11th at 7pm at the Clayton School common area.
