13. DEPARTMENTAL REPORTS

- i) Administration/Plan Commission/Zoning:
 - No Plan Commission meeting in November. Clerk/Treasurer Kazmierski provided information on Village audit, tax collections, working capital bridge loan extension, W-2's, February 16th Spring Primary, Election training and voting machine test day.
- ii) Public Works & Utilities:
 - Public Works Director Donath will attend WAPA Conference on February 23, 2016. Meeting room door will be installed within next two weeks. Cedar Corporation provided a status report regarding the WWTP project. Village is in need of replacement grinder pump. Motion by Anderson, seconded by Krueger to purchase \$2,300 grinder pump. Voice Vote: Ayes-7 Nays-0 motion passed.
- iii) Police Department:
 - There were 1,230 miles put on the squad in January. Also, in January there were: 4 arrests, 16 citations, 14 warnings, 26 training hours, 19 new cases investigated, 3 assists to outside agencies, 5 assists received from outside agencies, 2 court hours of court related matters, 1 animal complaints, and 2 hours of foot patrol. Police Chief Pickard attended Law Enforcement Management Conference on January 18-20 in Superior as well as AIS Shoot Don't Shoot simulator training in Clear Lake on January 21, 2016.
- iv) Fire & First Responders:
 - January report included there were 2 structure fire calls, 8 medical calls, and 2 false alarms. Water Rescue training was completed on January 25th.
- v) Ambulance:
 - No report, next Board meeting is February 22, 2016.
