Police:

Chief Murphy shared a handout with monthly activities. There were 30 calls for service; 3 citations issued and 3 warnings. The citations consisted of traffic related offences. On March 2 there was a narcotics search warrant conducted in the Village. Drugs, paraphernalia and money was recovered; 5 people were arrested during the warrant. Chief Murphy reported that there have been several burglaries to bars and laundromats throughout Polk County, including the Clayton Laundromat. Fortunately the Clayton laundromat had excellent surveillance cameras that caught the whole incident on video and was key in identifying both the vehicle that was used as well as descriptions of the burglary suspects. The suspects were caught in the act of burglarizing the laundromat in the City of Barron and were taken into custody.

Public Works & Utilities:

Sheldon Donath distributed the maintenance department report for review. The 3" radio read water meter is still on back order; 6" water meter for well 2 is still on back order. Sheldon reported that he had not received any results back for the well testing.

Fire & First Responders:

Fire Chief Bill Vanda reported that there were 4 medical calls in February. There were 2 events including the polar plunge with 39 jumpers; and the fire department provided food at the ice fishing contest on Lake Magnor.
