Department Reports

Administration / Planning Commission:

Joe Berghammer said he and staff spoke to Brian Roemer from Ehlers about the PSC Public Fire Charge and he thinks it would be beneficial for Ehlers to attend another Board meeting and refresh everyone's memory since it has been so long.

Dawn Nelson announced to the Board that Carol Wickboldt called and said that the Women's Club is disbanding after 30 years and will not be conducting the Village fund drive any longer. Discussion occurred. Harmoni Tower has made their 1st payment to the Village. The Clerk submitted an invoice for reimbursement from Harmoni for engineering and legal fees per the agreement. The Village office will be closed October 8th and 15th for training.

Police:

Chief Murphy shared a handout with monthly activities. There were 42 calls for service with no arrests; 3 citations issued and 7 warnings. He discussed proposals on video surveillance for in town.

Public Works & Utilities:

Sheldon Donath distributed the maintenance department report for review. Discussion topics included culvert replacement and 15th Street gravel. Sheldon said overlay can be done as resurfacing as long as the road rating is under 6.

Fire & First Responders:

Committee Chair Karrie Drinkman reported that there were 6 medical calls in September and the responders assisted with 2 fire calls. One call was a traffic crash with down powerlines. Chief Vanda added that it is National Fire Prevention this week. Due to Covid the responders are not allowed on school campus so they provided a youtube presentation for each class.

Parks & Rec:

Discussion topics included the Wayside Park and the playground equipment. LuAnn Scharmer said the largest piece of equipment that was \$25,000 has been purchased but the company is going to hold on to it until spring. October 12th there will be burger night fundraiser at 7 Brothers. A spaghetti night fundraiser on February 12th that will a meat raffle. And a night of kickball next year on August 6th that needs to be added to the school shelter calendar.
